



BLUE BINS ARE COMING IN 2023

The Town of Rocky Mountain House will provide blue bins to all residences in 2023!

Council has heard residential feedback on the curbside collection recycling program introduced in May 2022. The Town of Rocky Mountain House has had many requests for blue bins to help residents manage their mixed recycling materials.

240L



(same as current green and black bins)

360L



(default size for all residences)

Mixed recycling (paper, tin, cardboard and numbered plastics) are generally bulkier but weigh less than black bin and organic waste.

For this reason, the Town of Rocky Mountain House will be providing 360L curbside carts as the default size.

You will no longer need to provide clear or blue bags for your mixed recyclable materials. Blue bins will also speed up curbside collection, and reduce windblown materials. The estimated delivery for blue bins is late spring of 2023.

If your household would prefer a 240L bin (the same size as your current green and black bins), you *must* indicate your preference online at www.rockymtnhouse.com/p/blue-bins no later than January 27, 2023, or by phoning 403-845-2866.
