## WHO CAN VOTE?

All Canadian citizens 18 years of age or older who reside within the Town of Rocky Mountain House on Election Day.



## COME PREPARED!

All voters must show ID and proof of Rocky Mountain House residential street address — for example, the utility invoice enclosed with this newsletter. Please bring authorized voter identification that states your name and address, such as one of the following documents:

- Government-issued photo ID showing name and current address.
- Bank or credit card statement or personal cheque.
- Government cheque or cheque stub.
- Income or property/tax assessment notice.

- Insurance policy or coverage card.
- Residential lease or mortgage statement.
- Utility bill (power, internet, gas or water bill such as the invoice enclosed with this newsletter).
- Vehicle ownership, registration or insurance certificate.
