ELECTRONIC ASSESSMENT AND TAX NOTICES

The Town of Rocky Mountain House is introducing Electronic Assessment and Tax Notices.

Property owners who sign up for this service will receive a PDF file of their notice via email, along with any accompanying information bulletins that would be distributed by mail.

This will streamline and speed up the process of sending legislated notices to property owners, especially when there are two or more titled owners.

Property owners must opt in for this service.
