TITLE: Building Permit Fees

POLICY STATEMENT

To establish a written policy, as approved by Council, to outline the procedure for building permit fees for the Town of Rocky Mountain House.

ADMINISTRATION PROCEDURE

The fee for new building permits will be based on the estimated construction values of the project. For all building permits in the Town of Rocky Mountain House, a \$4 charge per \$1000 of construction value will be utilized. The minimum construction value factors for various types of construction types are provided in Schedule A. For construction values over \$1,000,000 the building permit fee charge will be decreased to \$3.2 per \$1000 of construction value. The minimum fee for a building permit will be \$60.00. All fees shall be paid at the time of issuance of a building permit.

In any case where there is discrepancy between an applicant's proposed construction value, and the minimum amounts determined from Schedule A, the Building Inspector or Director, Planning and Community Development will have final decision to determine fair construction value.

If construction is commenced prior to the issuance of the building permit, then all pertinent fees shall be **doubled**, and will not preclude the possible issuance of a stop order.

If the project is not constructed, the permit fees will be refunded **minus** the plan check cost, and the Safety Code fee.
